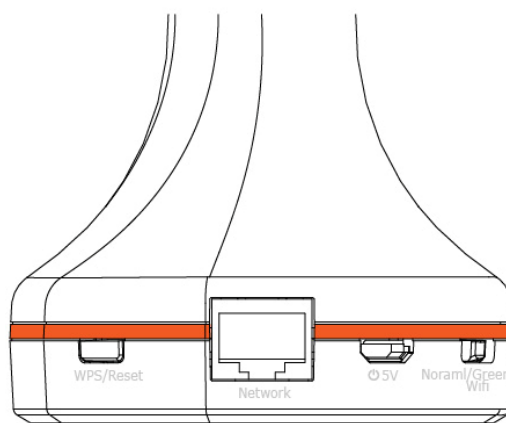
Instalacja

1. Podłącz BR-6288ACL do zasilania za pomocą załączonego zasilacza, bądź kabla USB.

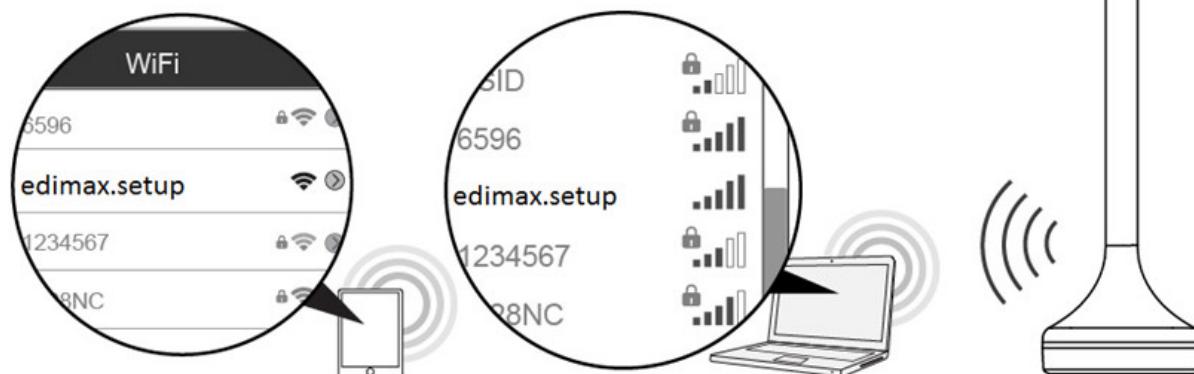
 **BR-6288ACL wymaga natężenia prądu 1A. Upewnij się, że gniazdo USB, z którego zamierzasz skorzystać, dostarczy tyle. Jeżeli nie, skorzystaj z zasilacza 5V.**



2. Poczekaj aż okrągły wskaźnik LED przy podstawie urządzenia zacznie migać "Pomarańczowym/Czerwonym" światłem.



3. Użyj urządzenia bezprzewodowego (np. komputera, tabletu lub smartfona) aby odnaleźć sieć bezprzewodową o nazwie "edimax.setup" i połączyć się z nią.

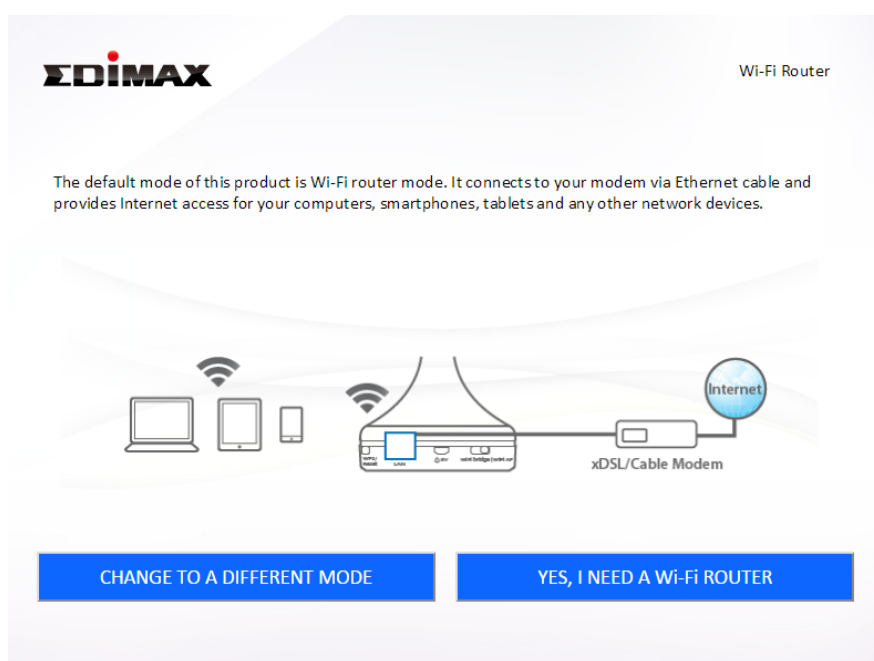

Splitter portów Ethernet

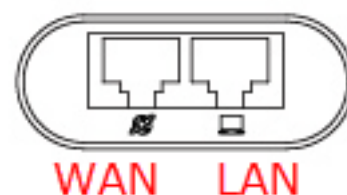

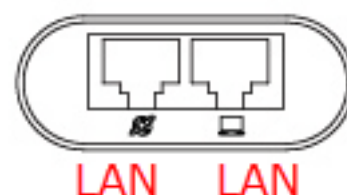
W trybie **routera bezprzewodowego**, jeden port Ethernet jest portem **WAN**, służący do połączenia z modemem.

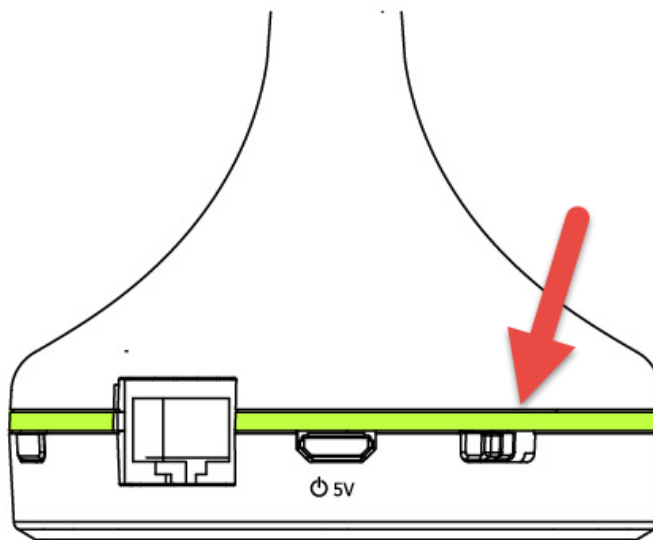

Regulacja mocy sieci bezprzewodowej

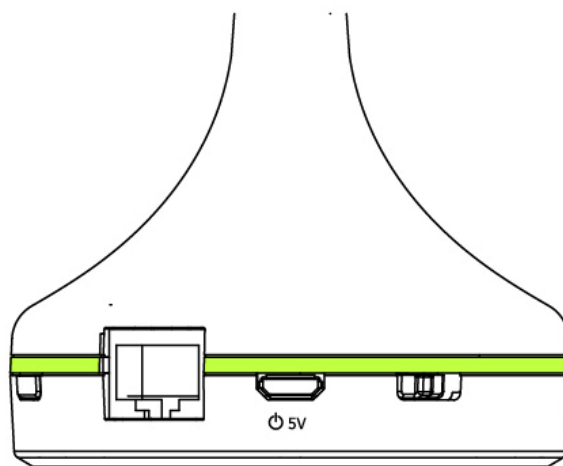

Rozwiązywanie problemów

1. Nie mogę połączyć się z Internetem.
