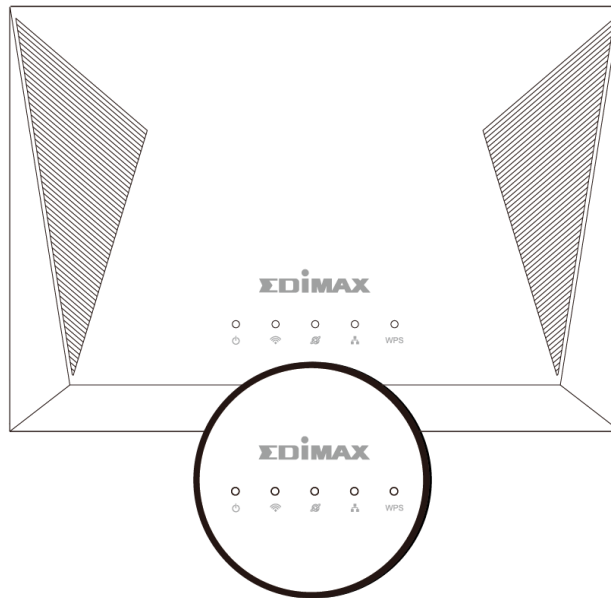
Инструкция

Установка

1. Подключите прилагаемый адаптер питания к порту питания 5 В постоянного тока устройства, а другой конец - к электрической розетке.



2. Убедитесь что светодиод питания горит. Если не горит, проверите подключение к питанию.





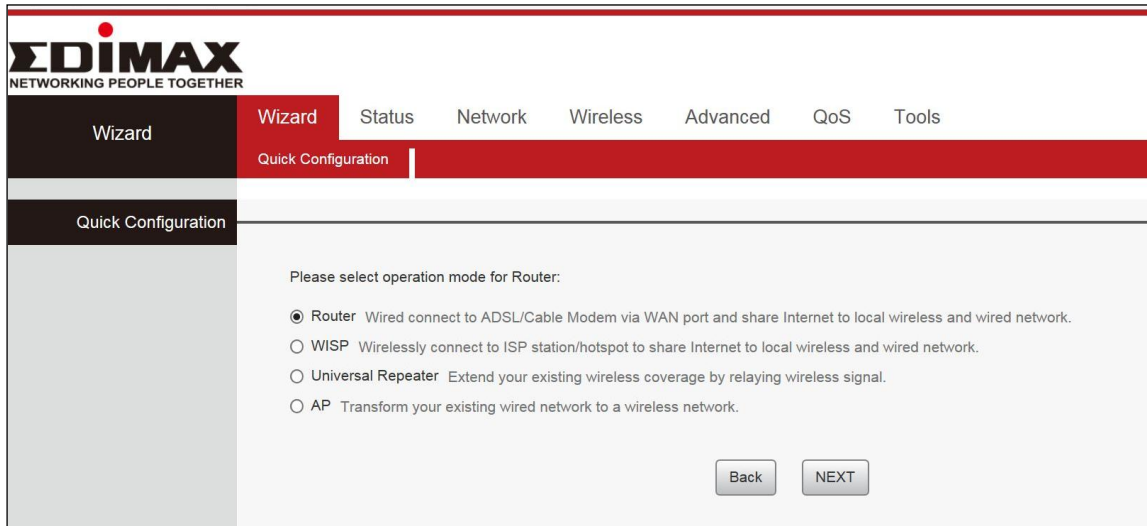

Решение проблем

1. Системный светодиод не горит.

- a. Убедитесь, что блок питания правильно включен и работает.
- b. Убедитесь, что маршрутизатор получает питание.
- c. Повторно подключите адаптер маршрутизатора к электрической розетке. Если индикатор системы все еще не загорается, обратитесь за помощью к местному дилеру.

2. WAN светодиод не горит.

- a. Проверьте сетевую кабель (RJ-45), правильно ли включен к маршрутизатору.
- b. Убедитесь, что другой конец кабеля Ethernet (RJ-45) правильно подключен к карте локальной сети компьютера или к порту Ethernet кабеля / xDSL.
- c. Убедитесь, что ваша компьютерная карта LAN правильно установлена и настроена.
- d. Убедитесь, что широкополосный доступ к кабелю / xDSL работает правильно и правильно настроен.
- e. Обратитесь к местному дилеру за технической поддержкой, если индикатор Ethernet по-прежнему не загорается после вышеуказанных процедур.

3. У меня нет доступа в интернет.

- a. Убедитесь, что все кабели подключены правильно. Попробуйте использовать другой кабель Ethernet.
- b. Проверьте, можете ли вы получить доступ к веб-интерфейсу конфигурации. Если нет, убедитесь, что ваш компьютер настроен на использование динамического IP-адреса. Если вы не знаете, как это сделать, обратитесь к руководству пользователя.
- c. Войдите в веб-интерфейс конфигурации и перейдите в Internet> WAN Setup и проверьте правильность типа подключения. Если вы не знаете, какой тип подключения к Интернету у вас есть, обратитесь к своему интернет-провайдеру (ISP).
- d. Подключите компьютер непосредственно к модему и проверьте, можете ли вы получить доступ в Интернет. Если вы не можете, обратитесь за помощью к своему интернет-провайдеру.

4. Я не могу открыть страницу настроек.

- a. Убедитесь, что ваш компьютер настроен на использование динамического IP-адреса. Если вы не знаете, как это сделать, обратитесь к руководству пользователя.

5. Как сбросить настройки на заводские?

- а. Чтобы вернуть заводские настройки по умолчанию, нажмите и удерживайте кнопку WPS / Reset более 10 секунд, пока индикатор питания не начнет мигать. Подождите несколько минут, чтобы продукт перезапустился. Когда устройство перезагрузится, все настройки будут сброшены. Настройки по умолчанию отображаются на этикетке продукта на задней панели устройства.

6. Я забыл пароль.

- а. Сбросьте маршрутизатор до заводских настроек по умолчанию и используйте администратор по умолчанию и пароль по умолчанию 1234. Настройки по умолчанию отображаются на этикетке продукта на задней панели устройства, как показано выше.

7. Удалить сеть Wi-Fi из моего компьютера.

Если вы измените настройки беспроводной сети на своем беспроводном устройстве, вы должны удалить их соответственно с вашего ПК; в противном случае вы не сможете подключиться к этому устройству по беспроводной сети. Ниже описано, как удалить беспроводную сеть с вашего ПК.

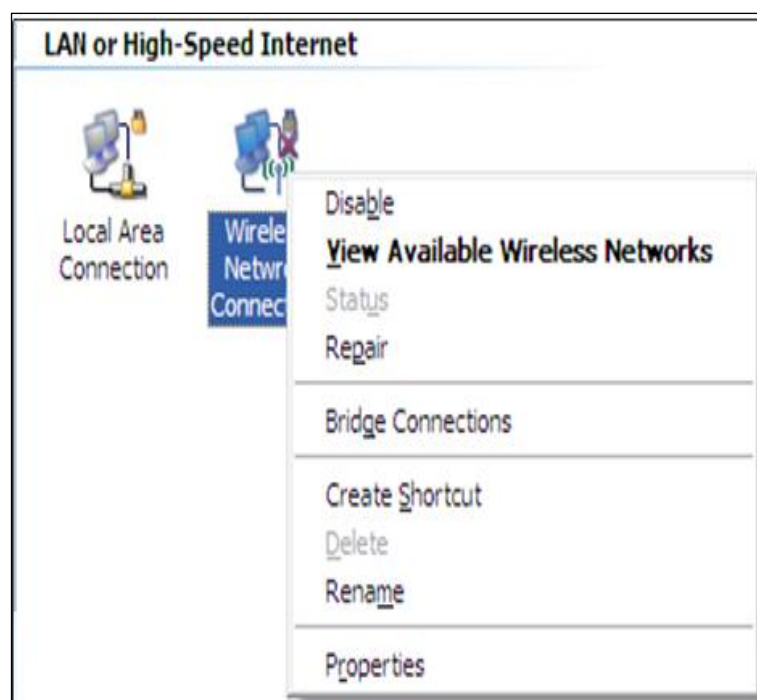

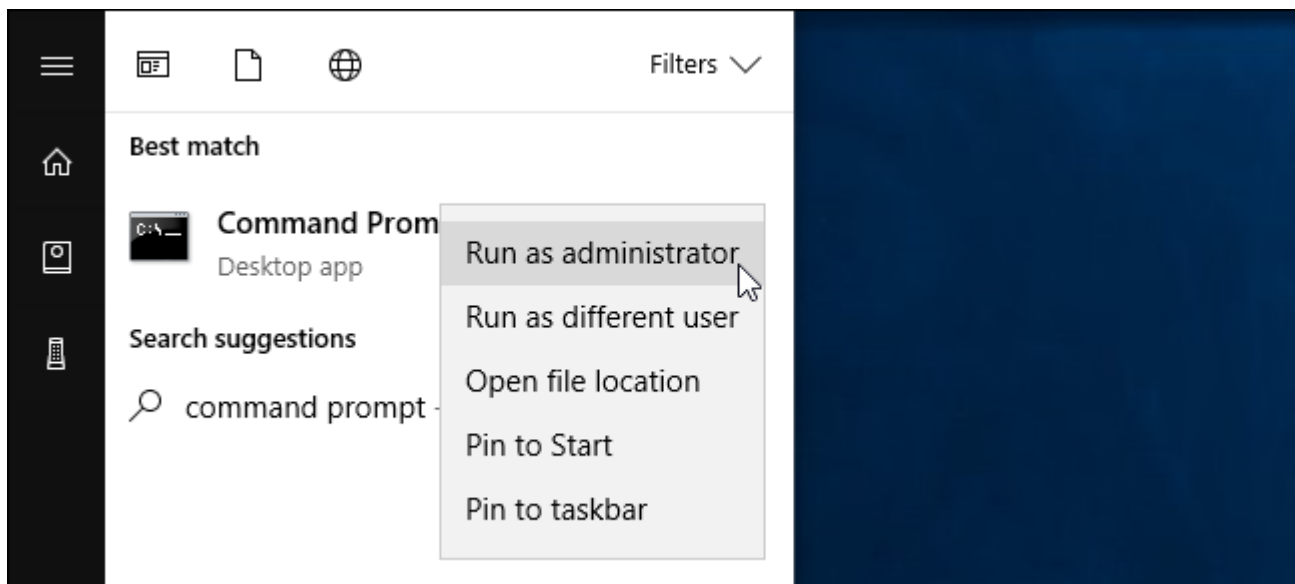

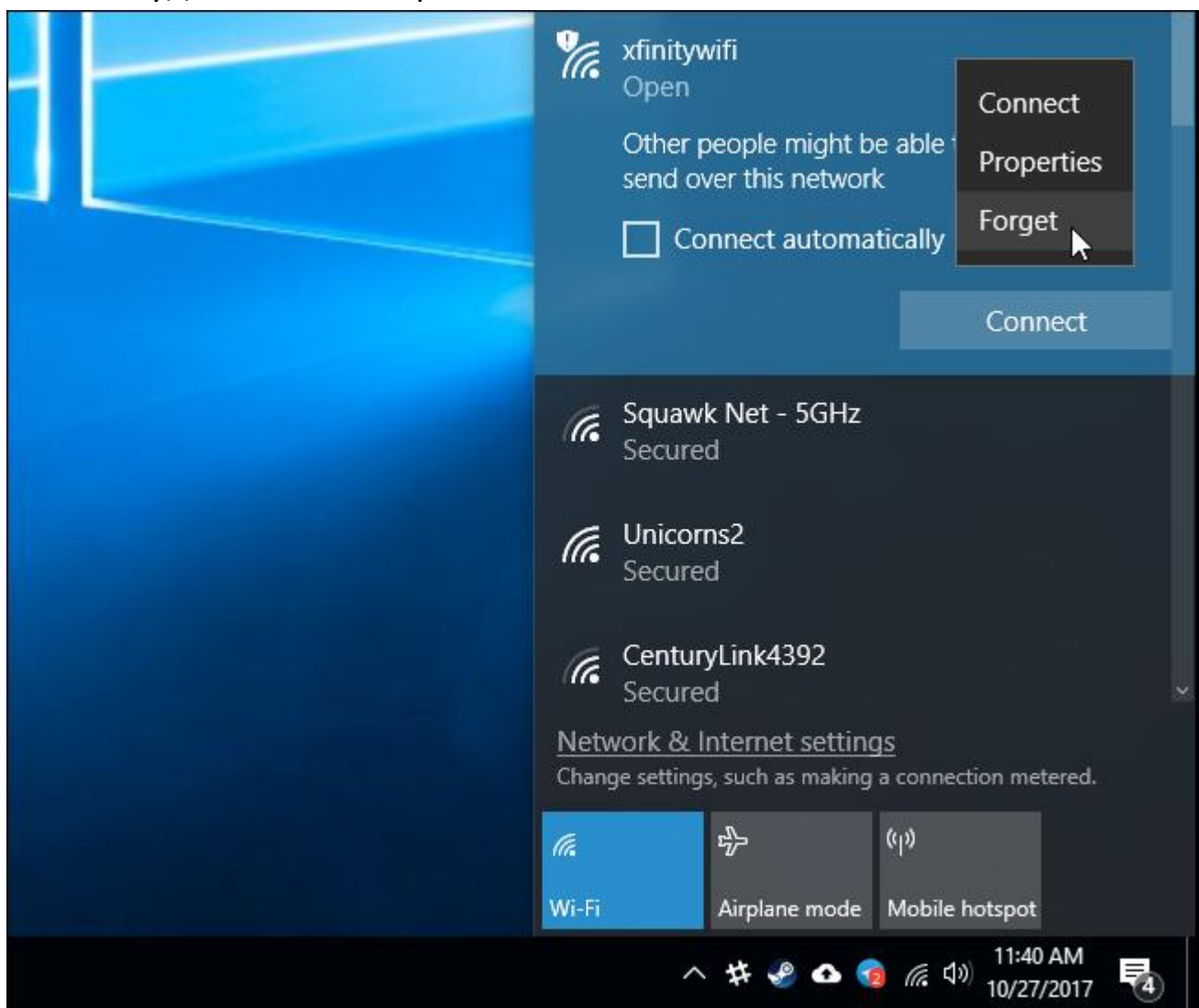
