Instalacja

1. Podłącz załączony zasilacz do gniazda zasilania 12V urządzenia oraz do gniazdka elektrycznego.



2. Upewnij się, że dioda zasilania świeci się. Jeśli nie, urządzenie nie jest prawidłowo podłączone.





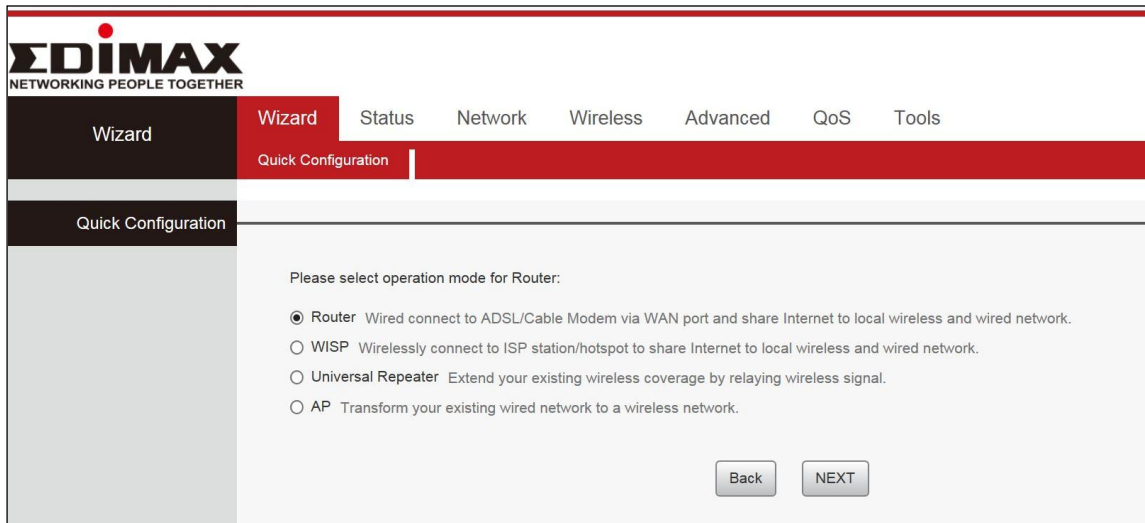

Rozwiązywanie problemów

1. Dioda System nie zapala się.

- a. Upewnij się, że zasilacz jest prawidłowo podłączony do gniazdka.
- b. Podłączając inne urządzenie, upewnij się, że gniazdko elektryczne jest sprawne i działa prawidłowo.
- c. Podłącz ponownie zasilacz do gniazdka. Jeśli dioda System nadal się nie świeci, skontaktuj się ze sprzedawcą w celu uzyskania pomocy.

2. Dioda WAN nie zapala się.

- a. Upewnij się, że przewód ethernetowy (RJ-45) jest prawidłowo podłączony do portu routera.
- b. Upewnij się, że drugi koniec przewodu ethernetowego (RJ-45) jest prawidłowo podłączony do portu LAN komputera lub modemu Cable/xDSL.
- c. Upewnij się, że karta LAN komputera jest prawidłowo zainstalowana i skonfigurowana.
- d. Upewnij się, że połączenie kablowe/xDSL działa i jest prawidłowo skonfigurowane.
- e. Jeśli dioda WAN nadal się nie świeci, skontaktuj się ze sprzedawcą w celu uzyskania pomocy.

3. Nie mogę uzyskać dostępu do Internetu.

Odczekaj kilka minut, aż urządzenie uruchomi się ponownie, a wszystkie ustawienia zostaną przywrócone do wartości fabrycznych. Ustawienia te podane są na etykiecie produktu, na spodzie urządzenia.

6. Zapomniałem moje hasło.

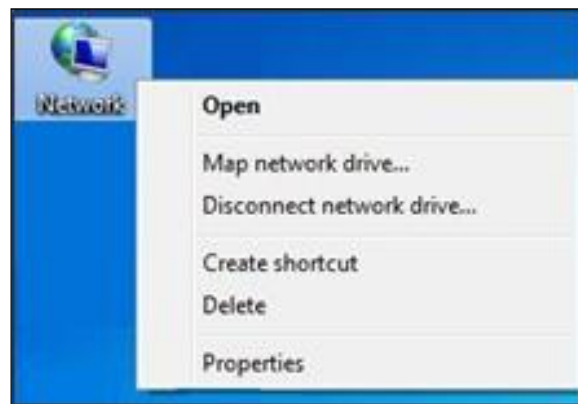

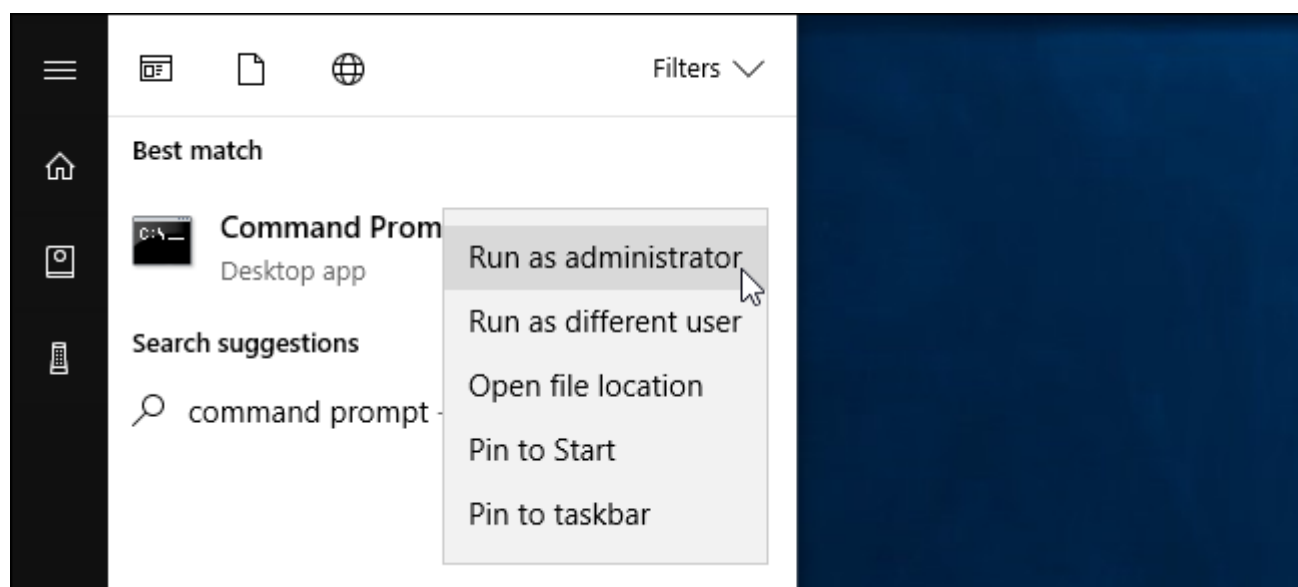
